### 3. Review and approval of December 2014 minutes

The minutes were reviewed. No changes, corrections nor additional information were requested. Motion to approve the December 2014 minutes (Johnson / Owings). Unanimously approved.

#### 4. Action Items: 2015 Events

SSA 24 has received a sponsorship request from Touhy Park for a total of \$1,200.00 to support their 2015 programming. Specific events include: Movie in the Park and Shakespeare in the Park. Motion to sponsor Touhy Park of the Chicago Park Districts with a total of \$1,200.00 for 2015 programming with the understanding that the park will provide the Commission a schedule of events (Johnson/ Owings). Unanimously approved.

Ana proposed the review of sponsorship levels for Glenwood Sunday Market and Clark Street Festival for 2015. Commission discusses pros and cons. Motion to sponsor Glenwood Sunday Market at \$16,000 level and Clark Street Festival at a \$10,000.00 level (Owings / Johnson). Unanimously approved.

Commission requested that in the future all events submit a type of proposal that include the value the event provides the SSA and the attendance as a reference when working on budgets.
