 - Landscaping 2017 Contract- the planters along Clark Street will follow a
 different contract as the original planters they will be planted to a total of 3
 seasons in order to save money.
 - Clark Street Revitalization- Sandi gave overview of plan. A consultant has been hired. The plan will take its course from now until the end of October. Wally will be the Commission representative in the Plan's Steering Committee
 - Live, Love, Shop Rogers Park the program was a success. There was a problem with some people abusing the rules. RPBA came up with a solution to avoid this from happening the following year.
 - Cinco de Mayo- Some business owners in the GAAD area would like to collaborate to put together an event for 5 de mayo. Carolina will help with marketing the event.
 - PINs with property taxes not paid in 2016- Carolina is doing some research to find out which property owners are not paying their taxes in order to maximize the SSA Budget.
